#### Motion No. 1, Item 24SUB 15/02/17

Motion received from Cllr Victor Isaacs regarding the plans for of the vacant land/erf on the corner of Link Avenue & Albatross Street, Macassar

 A meeting will be arranged with Mr von Moltke of Catchment & Stormwater & River Management Department to explain the reason why the erf on cnr Link Avenue & Albatross Street is now regarded as a flood plain and that they cannot develop the land.

#### Motion No 3, Item 24SUB 24/03/17

Motion received from Cllr Victor Isaacs to engage with Human Settlements and the Asla Development regarding to report on sell-off of land to private developers in Macassar Village

 Cllr Bazier stated that she is not sure whether this motion is going any because Asla is selling land in the back roads and these developments for R100 000 and there is some vacant erven and most of the spaces has been bought up by people which means that it now private land. She said the officials do not want to give any information on this even though we have given them guidance on how to obtain the information yet nothing is forthcoming. The greater Macassar Civic Association also had a meeting with Asla around the selling off land. They want to build a hall as part of their social responsibility and want to clean up their act as Asla has messed up. This is like the first motion where we will be getting no answers.

The Chairperson indicated even though we won't get any answers it will remain on the agenda until some kind of answer is given as no one wants to take responsibility. The official responsible is saying that this happened before his time. He also submitted another motion that the Human Settlements Department should investigate around the type of roofing that was installed in the BNG housing. According to the specifications it was supposed to be nutec roofing but that asbestos roofing was installed. He said this motion should feed into the motion of 24SUB 24/03/17 and that Asla should take responsibility and provide answers.

# **Progress Report: C3 Notifications**

- The Facilities Management Department is going to assess the whole building together with the Fire Department and they would come up with a plan if claim is about R10 million and the cost of repairs budget is R7 million then they would demolish and build a brand new facility to the amount of R10 million.
- While the Department is busy with the claim, service delivery should go on and that the officials should be back in Macassar assisting the community. In the interim Recreation & Parks has given approval to re-create the Old Civic Centre into office space to accommodate himself, his ward assistant and the officials.

Motion received from CIIr Victor Isaacs that the Subcouncil request a report and implementation to Subcouncil to all departments to identify projects under R30 000 to community based vendors in Ward 109

- There is movement on this project and he informed the business sector to encourage organisations to register their company on the community based vendor for the under R30 000 projects.
- Mr Manuel indicated that he remembers companies need to go to Cape Town to register their company and this makes it difficult for companies to register.
- Cllr Bazier stated that companies need not go to Cape Town the forms are available on the website or at the Cllrs office.
- Chrystal Frantz explained the whole process of how it works and the required documentation, which is needed for registration.
