5. **EXECUTIVE SUMMARY**

The Western Cape Liquor Act, 2008, as amended by the Western Cape Liquor Amendment Act, 2010 and Western Cape Liquor Regulations, 2011 were implemented on 1 April 2012. The Act was implemented in phases. With effect from the 1 July 2017, event and temporary liquor licence applications are submitted

to the City for comment. Council has delegated the authority to comment to the Subcouncils.

4(1) To comment on applications for liquor licences in terms of the Western Cape Liquor Act, 2008, as amended.

Where time or legal constraints do not allow the timeous submission of the matter to the Subcouncil, the Subcouncil manager, in conjunction with the chairperson relevant ward councillor and area director, has the sub delegated authority to deal with the matter.
