# 2. SUBJECT

SUBCOUNCIL WARD ALLOCATION ROLLOVER FUNDS AVAILABLE FOR REALLOCATION FROM THE 2021/22 TO THE 2022/23 FINANCIAL YEAR

#### 3. PURPOSE

The purpose of this report is for the Subcouncil to comment on the roll-over funds of R23 423 forthcoming from the 2021/22 financial year to be re-allocated to an existing approved or new capital project to be implemented within the 2022/23 financial year.
