## 3. PURPOSE

For the Subcouncil to approve the recommendation for an application for the extension of liquor trading hours in terms of Section 6(1) of the City of Cape Town: Control of Undertakings that Sell Liquor to the Public By-Law, 2013.

## 4. FOR DECISION BY

Subcouncil in terms of Delegation 4(2) To approve, refuse or vary applications for extension of trading days and hours on premises where

liquor licences have been granted in terms of Section 2 of the By-law: Control of Undertakings that Sell Liquor to the Public, 2012

## 5. EXECUTIVE SUMMARY

The City of Cape Town: Control of Undertakings that Sell Liquor to the Public By-Law, 2013, was promulgated on 17 January and coming into effect on 01 February 2014.

An application for extension of liquor trading hours in terms of Section 6 (1) of the By-law was submitted to the Health Directorate and circulated to the relevant departments for comment.

The fully signed application, including all required comments was submitted to the Subcouncil 3 Manager, and was then circulated to abutting neighbours, all organisations included on the **Ward 107** database and ward committee members for comment.

Clause 9 of the By-law requires that the City must, before approving an application for the extension of trading days and hours, reasonably and fairly consider further factors which must include, inter alia-

- (a) the validity of the liquor licence;
- (b) where applicable, the validity of a business licence issued in terms of the Businesses Act of 1991 (Act No. 71 of 1991);
- (c) location category as per the Schedule;
- (d) previous suspension, amendment or revocation of extended trading days and hours including previous records of complaints investigated and confirmed in respect of the last twelve months preceding a current application for extension;
- (e) the proximity of the licensed premises to surrounding residential zoned area, cultural, religious and educational facilities;
- (f) outcome of community consultation and the recommendation of the relevant ward;
- (g) the potential impact on the surrounding environment;
- (h) whether it is in the public interest to approve and grant an extension of trading days or hours; or

- (i) a motivation from the applicant dealing with the impact of
  - (i) the risks to and nuisances on the surrounding community;
  - (ii) mitigation measures to assist the control of risks and nuisances; and
  - (iii) possible benefits of extended liquor trading hours and days on the surrounding community.
- (j) The basis and rationale behind all decision-making must be recorded.

#### 6. DISCUSSION

- 6.1 Section 6 (1) of the By-Law reads as follows:
  6(1) Subject to subsection (5), (6) and (7) a licensee may upon payment of the required fee, submit a written application to the City to extend the liquor trading days and hours of licensed premises.
- 6.2 The following application for extension of liquor trading hours in terms of Section 6 (1) of the By-law has been received by the Subcouncil:

# Safety & Security (Liquor Control):

Pertaining to the mentioned premises, namely, Diamonds Discount Liquors, situated at corner of Link and Ravenscourt Roads, Parklands. it was ascertained that the applicant did renew his liquor licence for 2021. No complaints were received by the liquor unit with regards to this establishment. This application is recommended by SAPS.

## **RECOMMENDATION**

It is recommended that it be **NOTED** that an application for the renewal of extended liquor trading hours (off-consumption) in respect of , Diamonds Discount Liquors, situated at corner of Link and Ravenscourt Roads, Parklands for trading Mondays to Saturdays 18:00 – 20:00 and Sundays 11:00 - 18:00 was considered under sub delegated authority by the Subcouncil Manager, in consultation with the Chairperson of Subcouncil 3 and Ward Councillor and that the following decision was taken on the 1st of July 2021:

- A. That the application for the renewal of extended trading hours (off-consumption) submitted by Diamonds Discount Liquors situated at corner of Link and Ravenscourt Roads, Parklands for trading on Mondays to Saturdays 18:00 20:00 and Sundays 11:00 18:00 **BE APPROVED** as it complies with the criteria included in the City of Cape Town: Control of Undertakings that Sell Liquor to the Public By-Law, 2013.
- B. Should complaints be received concerning noise and/or unruly behaviour of patrons, these complaints will be investigated and may result in the extended trading hours being withdrawn and will also be referred to the Western Cape Liquor Authority which may jeopardise the renewal of the liquor licence.
- C. This approval is also subject to compliance with all relevant by-laws of the City of Cape Town.
- D. This approval will be valid for 12 months from the date of the decision subject to the possession of a valid liquor licence.
- E. That the extension granted is subject to the specific level of lockdown regulations applicable.
