#### 13ACT5/4/2022 MURP PRESENATION AND CAP SESSIONS - MURP

Mr Mphahlele Nkopodi said that there are MURP funded projects in Subcouncil 13 and that in Ward 37 there is a MURP project which focuses on Community Ambassadors and their role is to promote community safety within the boundaries of the ward, and coordinating service delivery in terms of safety and security of City of Cape Town officials.

It was agreed in the meeting that the Nyanga Precinct Management Project Manager must submit a full report to Subcouncil 13 detailing the project and how many ambassadors were appointed under Umtha Service Provider.

Mr Mphahlele Nkopodi said that the other responsibilities of the ambassadors were to identify and report all service delivery challenges in the wards and to monitor the progress of those matters as reported.

Mr Siviwe Ntaba concurred with Mr Mphahlele Nkopodi as to say that they are also dealing with service delivery issues such as the reporting of these incidents and also that in some areas they have implemented crime reduction activities as crime hampers service delivery.

Mr Lunga Bobo asked whether it is possible for other councillors to put monies aside for their Wards for this kind of project or similar projects.

Mr Monwabisi Booi responded by saying that the community ambassadors project is doable in other wards if there is funding available and further went on to say that MURP funding is not enough to cover all wards in Subcouncil 13.

Mr Monwabisi Booi said that Mr Ivan Anthony was responsible for MURP projects in Subcouncil 13 and that he must provide a progress report on all these projects.
