She stated the proposal is yet to be submitted to TFM and will cost R1.815 Million and will be engaging with TFM to request additional funding. She also stated there is no date scheduled at the moment for the meeting with TFM.

Ms. N Mdingi requested that the Department keep the Subcouncil posted on the TFM meeting to be scheduled.
