The purpose of this report is to transfer capital funds and to obtain authority to incur additional capital expenditure to enable the committed project WBS C08.84048-F2 : 132kV Interlock Replacement to proceed in the 2010/2011 financial year.

**5. EXECUTIVE SUMMARY**

Errors in the contractor's financial history files have resulted in the committed contract value being higher than anticipated in the mid year budget adjustment. This necessitates the transferring of funds from C08.84058-F2 : Century City where funds are available as a result of savings in the provisions made for variations in the rates of exchange and in the contract price due to variations in SEIFSA indices. No additional funding is required as the changes can be accommodated within the approved 2010/2011 Capital Budget.

## 7. DISCUSSION/CONTENTS

The contract for the replacement of the interlocking units was approved over three financial years commencing 2008/2009 and ending 2010/2011. The contract is subject to adjustment in respect of variations in the exchange rates and variations in SEIFSA indices. Due to the stability of the Rand against other currencies the allowance included in the contract amount to cater for these variances was too high. As part of the January 2011 Adjustments Budget the budget on WBS C08.840084-F2 was reduced from R10 303 450 to R6 395 000 based on the contractor's projection. It has become evident that there was an arithmetical error in the contractor's financial claim and payment spreadsheet. Consequently, the reduction in the budget was too large and an additional R2 717 000 is now required for the balance of the contract.

The additional expenditure can be met by way of the transfer of funds from project C08.84058-F2: Century City where funds are available as a result of savings in the provisions made for variations in the rates of exchange and in the contract price due to variations in SEIFSA indices.


