#### 6 EXECUTIVE SUMMARY

A number of amendments to the System which affect both the political as well as the administrative delegations is now proposed and submitted for decision by Council.

#### 8 DISCUSSION

As part of the ongoing exercise of review and amendment of Council's System of Delegations to ensure effective and efficient administration and service delivery, the Delegations compiled Administrative Task Team а set of proposed amendments/refinements based on inputs from various departments and councillors. This proposal was considered by the Political Delegations Task Team on 11 March 2011 and the finalised proposal is now submitted for consideration by Council. In the interests of saving paper and costs, only those pages affected by the proposals have been printed and are contained in Annexure B attached to this report. Explanatory notes motivating the specific amendments proposed are set out on Annexure A.

Once all the amendments proposed with this report are considered and resolved on by Council, they will be incorporated into the System of Delegations and published on the Council Website.

It will be necessary for those delegating authorities who are affected by the amendments and who have previously delegated or subdelegated these powers, duties

or functions, to re-issue delegations or subdelegations to delegatees in writing based on the amendments attached hereto.

It is to be noted that in terms of section 64 of the Municipal Systems Act 32 of 2000:

"The withdrawal, amendment or lapsing of a delegation or subdelegation does not invalidate anything done as a consequence of a decision taken in terms of that delegation or sub-delegation."
